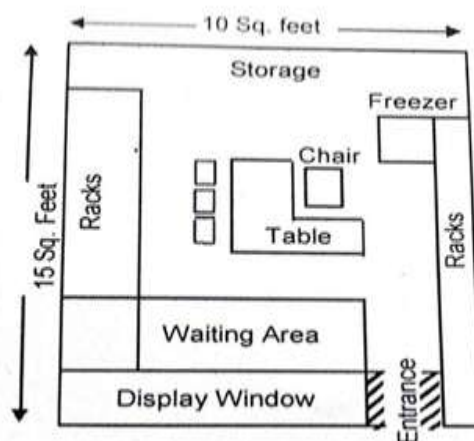
I. INTRODUCTION:
